SEE Law Journal Call for Papers – January 2020

The South East European Law School Network is glad to announce the **Call for Papers** for the **new edition** of the **SEE Law Journal**.

The South East European Law Journal (SEE Law Journal) is a scientific English language journal of the South East European Law School Network (SEELS). The SEE Law Journal publishes high-quality original, double peer-reviewed scientific, review and professional articles focusing on relevant questions of regional, European and international integration of SEE countries, issues of legal reform and approximation with the *acquis communautaire*, best practices, in legal reform and unification of the legislation in the region of South East Europe and the EU.

Starting from this one, the new editions will be published by the SEELS network in e-format only, following the successful continuous publication of the journal in the past 3 years under the support of the Erasmus+ Jean Monnet Activities Programme of the EU within the *Strengthening the EU Law Studies in EU project*.

As for the well-established practice, this edition will also be published solely in English Language and will be available online for free download to all interested parties. Additionally, we will start the process of registration of the SEE LJ to several relevant data bases in the upcoming period, which we hope, will add to its relevance. We strongly believe that this publication has a proven potential to promote the exchange of knowledge and views on the development of the legal systems in South Eastern Europe (SEE) in accordance with EU law. We expect that these editions will stimulate the EU law research and will further explore relevant national legal issues in an effort to provide deeper insight in the legislative requirements for the current legal developments both in EU and the region

In that sense, we cordially invite you to submit your contributions for the new edition of the SEE Law Journal. The SEE Law Journal is open for submission of articles prepared by the academics of the SEELS network, be it PhD candidates (junior researchers) or for submissions prepared in collaboration by at least one academic staff member and junior researchers (PhD students) of the SEELS members. The authorship is restricted to maximum three co-authors per article. In addition to this the SEE LJ with accordance of the amendment of its Editorial Policy is open for submissions from interested researchers who are not exclusively coming from the SEELS network provided that their focus of interest is related to the EU law.

The amended Editorial Policy also allows the publication of non-scientific papers, which are dealing with EU Law topics from a practitioner's point of view, thus allowing to the researchers / academics as well as the legal practitioners from the region to contribute with their reviews, analyses, opinions, etc... allowing for a wider more complex view. These contributions are not subject to double peer review, but are reviewed and approved for publication by the Editorial Board of the journal. They too should be submitted in English Language solely.
